

Pitt-Greenville Airport Authority Held on Wednesday, January 15, 2020 at 11:30 am Conference Room of the Pitt-Greenville Airport

Board Members in attendance were: Eric Clark, Chairman; John Banks, Vice-Chairman; Buddy Zincone, Secretary/Treasurer; Dr. Jim Morris; Mayor PJ Connelly; Dr. Dan Mayo Chris Nunnally and Terry Monday.

Chairman Clark called the authority meeting to order and confirmed there was a quorum. Clark proceeded to open the Public Comment Period and explained the procedures to be followed by those wishing to speak. Chairman Clark then invited any members of the public to come forward. With no members from the public present, the public comment period was closed.

Chairman Clark then addressed the board meeting minutes held on December 18, 2019. A motion to approve was made by Chairman Clark to approve with adjustments to previous graphs to reflect the correct months. Motion second by Buddy Zincone.

Chairman Clark welcomed new PGV Airport Authority Board member Chris Nunnally who has replaced Mike Fitzpatrick.

Executive Director's Report:

- Doggy Day out with Mercy from the Pitt County Animal Shelter. He was adopted by one of PGV staff members.
- Touch-A-Truck April 18, 2020 with the Youth League. Looking for sponsors to provide an airplane or helicopter for the event.

Economic Development:

- Discussions concerning the 90 acres

- PGV partnering with Greenville-Pitt Chamber of Commerce's Grow Local program



PGV has looked into possible Internships. We have reached out to Lenoir Community College's Aviation Management, Pitt Community College and Elizabeth City State University.

Chairman Clark mentioned the Grow Local Program. Mr. Hopper informed Chairman Clark that we are already registered as a Business Host for the Grow Local program and waiting for a school match possibly by April 2020.

Chairman Clark wanted to know how is PGV able to utilize social media and the website to promote the airport more.

Rena Bunns commented that we have been more active in promoting the airport through social media, the website and going out into the community more.

Vice-Chairman Banks inquired as to how many press releases were being done each month. Mr. Hopper advised him that there weren't a whole lot being done currently, but will increase the numbers in the future.

Chairman Clark recommended that we look into posting information on the City community channel.

Project is moving forward fast. Mr. Hopper announced that he would be meeting with the GA community around March or April.



- Base sales have increased









Passenger Counts

- Demand continues to grow at PGV









Parking Lot:
