Chairman Banks introduced Jason Arnold from TA Loving,
Chairman Banks asked Jason to explain to the Board how state
and federal funds work regarding construction projects. Jason
discussed delivery methods, bidding process, CM- at
risk/negotiated GC and design build. Jason Arnold stated the
benefits of negotiating public GC versus a private GC. Chairman
Banks stated that Pitt Greenville Airport will be entering another
big spending season in 3-5 years. Especially for the General
Aviation, North 24, Runway 8 & 26, and other projects.

Southern Bank

Scot Webster stated that he was representing Brooks Bunting, Webster also stated that Brooks Bunting will attend the next Board meeting. A motion to roll the Hangar project for 1 year was made by Dan Mayo, seconded by Les Robinson motion unanimous, motion carried, motion approved. Lori Martin stated that she will have a review of Pitt Greenville Airport accounts prepared at the next Board meeting, Chairman Banks asked if Lori could send it out a week in advance.

Closed Session

To establish, or to instruct the public body's staff or negotiating agents concerning the position to be taken by or on behalf of the public body in negotiating (i) the price and other material terms of a contract or proposed contract for the acquisition of real property by purchase, option, exchange, or lease. A motion to go into closed session was made by Dan Mayo, seconded by Chris Nunnally motion was unanimous, motion carried, motion approved.

A motion to come out of closed session was made Dan Mayo, seconded by Mark Porter, motion was unanimous, motion carried, motion approved.

Executive Director

• Executive Director Bill Hopper was seeking endorsement of the FAA ACIP from the Board. Pitt Greenville Airport has FAA AIG Funds in the amount of \$1,335,200 that will expire June 30th 2025 if not used or encumbered by contract. The funds had been allocated as a part of the North 24 project. Hopper stated that due to the unanticipated delays in rezoning the property, the start of the project is now 15months behind schedule which in turn means the funds need to be reallocated to a project that can encumber the grant prior to expiration.

Executive Director Bill Hopper and Zach Staff from Mcfarland Johnson reviewed the FAA ACIP to identify

potential projects that meet the expiration date of June 30th 2025. The solution both parties came up with is to move up the critical portion of the \$4 million Perimeter Fence & Road Project which was scheduled for FAA FY 2027. Hopper stated that the earlier phase of the project that will be started this year is \$1,400,000 (\$1,335,200 FAA Funding and \$64,800 NCDOT Funding) expending the expiring FAA funding. The remaining slated for 2027 is \$2.6 million (\$2.34 million FAA Funding and \$260,000 PFC). A motion to move up the Perimeter Fence & Road Project was made by Dan Mayo, seconded by Terry Monday motion was unanimous, motion carried, and approved.

 Executive Director Bill Hopper stated that he received a quote from Independent Fee Estimates, LLC in the amount of \$2,660 to do a required IFE for Mcfarland Johnson, Inc to do the Environmental Services for the North 24 Project. This has been approved by Chairman Banks.

Parking Booth

Operations Manager John Hanna stated that Pitt Greenville Airport staff has started logging tickets and the freebies that were given out. The past 11 months the parking machine has been down 999 hours. Hanna stated that the camera system that reads the licenses plate is also down. Pitt Greenville staff has also started tracking conference room events as well as ECU charters. Chairman Banks stated that he wants an email of the average pay it would cost to have an employee in the parking booth before the next meeting.






