#### **Public Comment Period**

With no one registered to speak, Chairman Banks closed the Public Forum and called the monthly Airport Authority Board meeting to order.

#### **Approval of Minutes**

Board Minutes from the December 11<sup>th</sup> 2024, Pitt Greenville Airport Authority Board meeting were emailed to all members for review. Chairman Banks asked if there were any changes or recommendations to the minutes. With no corrections, a motion to approve the minutes was made by Dan Mayo, Chris Nunnally, motion was unanimous, motion carried, minutes were approved.

#### **Executive Director Report**

- Executive Director Bill Hopper stated that Pitt County Sheriff's
  office contract will be increasing from \$42.50 to \$47.50. Motion
  to approve pending Dave Silver reviewing contract was made by
  Chris Nunnally, seconded by Mark Porter.
- Executive Director Bill Hopper stated that he received approval for the Gas Fired Unit Heater Replacement at Fire Station-Eneco East in the amount of \$3,795 from Chairman Banks.
- Executive Director Bill Hopper stated that he received approval for Legal counsel for North 24 zoning-Ward & Smith in the amount of \$3,965 from Vice Chairman/Treasurer Terry Monday.
- Executive Director Bill Hopper stated that the FAA required
   Independent Fee Estimate for North 24 Environment-Independent
   Fee estimates, LLC in the amount of \$2,660 from Chairman Banks.
- Executive Director Bill Hopper was seeking approval from the Board to enter into an agreement with McFarland Johnson, Inc for

Environmental Services for North 24 Development Project in the amount not to exceed \$234,700. Pitt Greenville Airport conducted the FAA-required Independent Fee Estimate and McFarland Johnson is 6% below the amount determined by the IFE contractor. The IFE estimated \$248,958 to perform the needed work. Motion to approve was made by Chris Nunnally, seconded by Mark Porter.

#### **Operations Report**





#### **Parking Booth**

PGV Parking lot follow up and update costs. Employee's vs cost of parking booth software, payback benefit, revenue estimate, quote on replacement of actual parking booth and costs to repair. Chairman Banks wants a comparison analysis of parking with Jacksonville, Newbern, and surrounding Airports. Chairman Banks also wants a benefit analysis, payback & total based on needs and wants from Executive Director Bill Hopper, Operations Manager John Hanna, and Finance & Administrative Manager April Cannon.

#### **Finance Report**

Finance Manager April Cannon stated that Pitt Greenville Airport is still operating in a \$30,000-\$60,000 loss over the past few months. Fuel sales are down due to 3 Hangars being vacant. Transfers will start to occur for operational loss from reserves in the coming months pending discussions with consultants. The Engineering and PFC consultants are also looking into NCDOT funds to figure out where the rest of the local funds will come from.

NCDOT funds are required to be encumbered by set time frames. If there are any grants that has funds unable to be encumbered by there current projects, this can be used for local share of current AIP projects with approval.

April Cannon stated that the Board will see changes on the balance sheet over the next couple months once all transfers are complete with Consultant guidance and board approval.

#### **Closed Session**

To establish, or to instruct the public body's staff or negotiating agents concerning the position to be taken by or on behalf of the public body in negotiating (i) the price and other material terms of a contract or proposed contract for the acquisition of real property by purchase, option, exchange, or lease. A motion to go into closed session was made by Dan Mayo, seconded by Chris Nunnally motion was unanimous, motion carried, motion approved.

A motion to come out of closed session was made Dan Mayo, seconded by Mark Porter, motion was unanimous, motion carried, motion approved.

#### **Chairman Comments:**

Chairman Banks stated that he would like for the Board Members and Pitt Greenville Airport to come together with ideas for local share project funds.
